Re: Release of OEB staff research paper Examination of Alternative Price

Designs for the Recovery of Global Adjustment Costs from Class B

Consumers in Ontario

Ontario Energy Board File No. EB-2016-0201

In 2015, the OEB published the <u>Regulated Price Plan (RPP) Roadmap</u>. The <u>Roadmap</u> sets out a multi-year plan to redesign the RPP to better respond to policy objectives, improve system efficiency, enhance consumer literacy and understanding to better empower customers and give them greater control. To this end, the OEB launched a number of pilot projects testing alternative RPP price plans and other features last year.

Another key element of the plan is evaluating how to improve the way in which Global Adjustment (GA) costs are collected through electricity prices paid by consumers. The *Roadmap* points out that the price signal RPP time-of-use customers face gives an enhanced incentive for providing demand response relative to the uniform GA cost that a non-RPP Class B consumer must pay regardless of the time that power is consumed. *The Roadmap* proposes that a consistent approach to the recovery of GA costs from Class B consumers would be more equitable and could underpin the development of a range of price options that could more effectively address consumer expectations.

As a step towards improving electricity pricing structures, the OEB today released a staff research paper entitled <u>Examination of Alternative Price Designs for the Recovery of Global Adjustment Costs from Class B Consumers in Ontario</u>. This paper describes analytical research evaluating a variety of generic GA pricing options on the basis of economic efficiency and consumer cost impact. The analysis considers all Class B consumers, both those who are enrolled in the RPP and those who are not.

OEB staff intends to solicit comments from interested parties – including, specifically, organizations which represent commercial customers – within the electricity sector on the

policy and economic merits of alternative price designs for recovering GA costs, especially in the context of those customers who pay GA costs directly.

Supported by the options analysis developed in the paper, OEB staff also intends to engage with a range of consumers and consumer groups to better understand their priorities and preferences regarding pricing as well as considerations such as the feasibility of integrating demand response into their business processes. It will also conduct further impact analysis at the consumer level, including looking at the impacts by business type, geography and other potentially relevant factors. The results of RPP pilots, when available, will also inform further pricing work as it pertains to residential and other low-volume consumers.

These steps are key inputs to the development of a robust framework for future price plans for all Class B customers. Such a framework is expected to include new pricing plan(s) for customers eligible for the RPP. Potential also exists for a proposal for a revised pricing framework for other Class B customers. As indicated in the Roadmap, the OEB is committed to working with the government and the Independent Electricity System Operator (IESO) to put in place a pricing framework for all Class B customers that better supports policy objectives, promotes efficiency and enhances customer control.

To discuss the methodology and results of the paper and to answer any questions interested parties may have, the OEB will host a **stakeholder meeting** on **March 21, 2019** in the West Hearing Room, 25th floor, 2300 Yonge Street, Toronto from 2:00 p.m. to 4:00 p.m. It will be broadcast over the web to allow remote participation.

# Appendix A Cost Award Matters

## **Cost Award Eligibility**

The OEB will determine eligibility for costs in accordance with its <u>Practice Direction on Cost Awards</u>. Any person intending to request an award of costs must file with the OEB a written submission to that effect by **March 12, 2019**. The submission must identify the grounds on which the person believes that it is eligible for an award of costs (addressing the OEB's cost eligibility criteria as set out in section 3 of the *Practice Direction on Cost Awards*). An explanation of any other funding to which the person has access must also be provided, as should the name and credentials of any lawyer, analyst or consultant that the person intends to retain, if known. All requests for cost eligibility will be posted on the OEB's website.

If an OEB licensed electricity distributor has any objections to any of the requests for cost eligibility, such objections must be filed with the OEB by **March 18, 2019**. Any objections will be posted on the Board's website. The OEB will then make a final determination on the cost eligibility of the requesting participants.

## **Eligible Activities**

Cost awards will be available in relation to the submission of written comments on the staff research paper and participation in the associated stakeholder meeting.

The maximum number of hours allowed per participant for the eligible activities are:

Written Comments on staff research paper	12 hrs
Preparation, Attendance and Reporting on Stakeholder Meeting	6 hrs
