Tips on how to hold a 'do-it-yourself' discussion

- 1 Set a time and place for your meeting. It could be a regularly scheduled council meeting or a meeting specifically called to start this discussion
- 2 Make sure that everyone who is going to participate in your discussion has read or has a copy of the First Nation & Métis Consultation Backgrounder and the First Nation & Métis Discussion Guide (both available at ontarioenergyboard.ca/oebenergyeast)
- 3 Use the three questions that are on the back page of the Discussion Guide (and on the worksheets that are part of this Conversation Toolkit) to focus your discussion
- 4 Encourage everyone to participate in the discussion and share their views
- 5 Make sure that someone takes notes (you can use the worksheets on Pages 2 and 3) and review the notes with everyone before you wrap-up the discussion to make sure all the key points have been captured
- 6 It's okay if people disagree – the discussion notes can reflect where people agreed on things and where they didn't
- 7 Send us the notes from your discussion (see Page 4 for instructions)
