

Presentation Guidelines

March/April

In Part One of the Energy East Consultation, the OEB will be seeking the views of Ontarians on the potential impacts (both positive and negative) of TransCanada's proposed Energy East Pipeline that are important to them. At each of the 7 community discussions being held in Part One, there will be an opportunity for local resident and community-based organizations to add to the discussion with brief presentations.

- There's time on the agenda for up to 9 organizations to present (see full agenda on page 2)
- There's 5-10 minutes for each organization to present (dependent on the number of organizations that wish to present).

At each Community Discussion:

- 30-45 minutes for local presentations
- 5-10 minutes for each organization
- Time for up to 9 organizations
- Send us your materials at least two business days in advance

Suggested Key Points to Cover

- We suggest you cover the same two focus questions that are on the agenda (see page 2).
- We also suggest that you include a description of the interests that your organization represents/the constituency that your organization serves.

Potential Areas of Impact to Consider

Ontario's Minister of Energy requested that the OEB consider the implications of four areas of potential impact. You can choose to speak to all, some or none of these potential areas of impact.

- The impacts on Ontario natural gas consumers in terms of prices, reliability and access to supply, especially for those consumers living in eastern and northern Ontario
- The impacts on pipeline safety and the natural environment in Ontario
- The impacts on Aboriginal communities in Ontario, in particular how treaty and Aboriginal rights may be affected
- The short and long term economic impacts of the project in Ontario
