NOTICE OF APPLICATION AND HEARING

Abitibi-Consolidated Company of Canada - Application for Licence Amendment **ACH Limited Partnership - Application for Electricity Generator Licence** ACH Limited Partnership - Application for Electricity Retailer Licence

Abitibi-Consolidated Company of Canada and its affiliate, Orion Limited Partnership (now known as ACH Limited Partnership), filed licence applications on June 2, 2006. The applications will be decided by the Managing Director, Market Operations, who has been delegated this authority pursuant to section 6 of the Ontario Energy Board Act, 1998 (the "Act").

Abitibi-Consolidated Company of Canada

Abitibi-Consolidated Company of Canada ("Abitibi") filed an application for an amendment to Schedule 1 of its electricity generator licence, EG-2003-0204. The Board has assigned the application file no. EB-2006-0175. The requested amendment is to change Abitibi's status as owner and operator of eight hydroelectric generating stations to operator only. Abitibi requested that its owner and operator status for the Westcoast Power Holdings Cogen Plant remain unchanged.

ACH Limited Partnership

Orion Limited Partnership ("Orion") filed applications for an electricity generator licence and an electricity retailer licence with the Board under section 60 of the Act. The Board assigned these applications file no. EB-2006-0124 and EB-2006-0128 respectively. The general partner for Orion was listed as 4349440 Canada Inc.

The Board issued Notice of Application by Orion for an electricity generator licence and an electricity retailer licence on June 30, 2006. No responses were received. Orion has since informed the Board that Orion's name had been changed to ACH Limited Partnership ("ACH LP") and that the name of its general partner had been changed from 4349440 Canada Inc. to Abitibi-Consolidated Hydro Inc. Accordingly, a Notice of Application is being reissued for each application.

Copies of the applications are available for public inspection at the Board's office and at Abitibi's offices at the addresses noted below.

How to Participate in the Hearing

The applications will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in these matters, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicants within 5 days of the publication date of this notice or the date you were served with this notice (as applicable).

If you wish to participate in the written hearing, please file a written submission setting out your views on the application(s). If you are making a submission on only one of the applications, only put the file number for that application on your submission. If you want your submission to be added to the record of more than one of the applications, please put all of the applicable file numbers on your submission.

You must forward three paper copies, and if possible, an electronic copy in Word format or in searchable PDF format, of your submission to the Board and one copy to the applicant at the addresses below. All submissions must be received no later than 10 days after the publication date of this notice or the date you were served with this notice (as applicable). If Abitibi and/or ACH LP wish to respond to the submissions, such response must be filed with the Board and copied to any party that made submissions no later than 20 days after the publication date of this notice.

All submissions must quote one or all of file nos. EB-2006-0175, EB-2006-0124, EB-2006-0128, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
