#### NOTICE OF APPLICATIONS AND COMBINED HEARING

# CONNECTION PROCEDURES SUBMITTED BY HYDRO ONE NETWORKS INC. AND GREAT LAKES POWER LIMITED PURSUANT TO THE ONTARIO ENERGY BOARD'S TRANSMISSION SYSTEM CODE

Section 6.1.5 of the Ontario Energy Board's Transmission System Code (the "Code") requires transmitters to file connection procedures for review and approval by the Board. The connection procedures are designed to facilitate processing requests to connect new or modify existing connections to a transmitter's transmission system. On August 18, 2006, Hydro One Networks Inc. ("Hydro One") filed its connection procedures with the Board. On August 21, 2006, Great Lakes Power Limited ("Great Lakes") filed its connection procedures with the Board.

The Board has assigned file no. EB-2006-0189 to Hydro One's application and has assigned file no. EB-2006-0200 to Great Lakes' application.

# Particulars of the Proceeding

Under the Code, transmitters are required to file their connection procedures with the Board for approval. The connection procedures must comply with the Code and, in particular, must contain the elements identified in section 6.1.4 of the Code.

Consideration of the two applications will likely raise similar issues, and it is expected that persons interested in one application may well have a similar interest in the other. Accordingly, the Board considers it appropriate to consider these two applications together. The Board will therefore conduct a combined proceeding in relation to the two applications in accordance with section 9.1 of the *Statutory Powers Procedure Act* and section 21(5) of the *Ontario Energy Board Act*, 1998.

## **How to Obtain Copies of the Connection Procedures**

Copies of Hydro One's connection procedures are available upon request from the offices of Hydro One Networks Inc. at the address noted below. Copies of Great Lakes' connection procedures are available upon request from the offices of Great Lakes Power Limited and the offices of counsel for Great Lakes, at the addresses noted below.

Copies of both Hydro One's and Great Lakes' connection procedures are available on the Board's website at <a href="www.gov.on.ca">www.gov.on.ca</a> and at the offices of the Board during normal business hours.

#### **How to Participate**

You may participate in this combined proceeding in one of three ways:

You may send the Board a letter of comment. Your letter should indicate any request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the date of this Notice.

You may request observer status in order to receive documents issued by the Board in the combined proceeding. Your request must be made by letter received by the Board no later than **10 days** from the date of this Notice.

You may request intervenor status if you wish to actively participate in the combined proceeding. Your request must be made by letter of intervention received no later than 10 days from the date of this Notice. Your letter of intervention must include a description of how you are, or may be, affected by the combined proceeding; and if you represent a group, a description of the group and its membership. The Board intends to proceed with this combined proceeding by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. Your letter of intervention should indicate any objections you have to the Board holding a written hearing in this matter. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs and the grounds for your eligibility for costs. Any costs to be awarded will be recovered from Hydro One and/or Great Lakes, as applicable.
