**Multi-year Electricity Distribution Rate Setting Plan** Re:

Selection of Electricity Distributors for Rebasing in 2009

Last year, the Chair of the Ontario Energy Board announced that the Board had established a multi-year electricity distribution rate setting plan for the years 2007 to 2010. As part of this plan the Board will identify which electricity distributors will have their rates rebased for each of 2008, 2009 and 2010. The criteria to be used by the Board for this purpose are set out in the Board's March 12, 2007 report entitled LDC Screening Methodology to Establish a Rebasing Schedule for Electricity LDCs<sup>1</sup> and have already been applied in identifying the distributors whose rates will be rebased in 2008. The preliminary list of electricity distributors whose rates are expected to be rebased in 2009 will be issued for comment in January, 2008. The final list will be issued in February, 2008.

As before, distributors will have an opportunity to self-nominate for rate rebasing. Distributors wishing to self nominate for rate rebasing in 2009 must file a letter to that effect with the Board Secretary by 4:30 p.m. on November 23, 2007. The letter must include the justification for the self-nomination, must quote file number EB-2006-0330 and include your name, postal address and telephone number and, if available, e-mail address and fax number. An electronic copy must be provided, and may be sent by email to boardsec@oeb.gov.on.ca.

Distributors that have already self nominated for rate rebasing in 2009 do not need to resubmit a nomination.
