**Re: Multi-year Electricity Distribution Rate Setting Plan
Final Selection of Electricity Distributors for Rebasing in 2009 and 2010
Board File No.: EB-2006-0330**

On January 2 2008, the Board issued for comment the lists of electricity distributors whose rates are proposed to be rebased in 2009 and 2010. The reasons for selection of these distributors were identified in Appendices A and B in the January 2nd letter.

The Board received comments from two licensed distributors in response to its January 2nd letter, one from Essex Powerlines Corporation requesting that the Board consider deferring its rate rebasing until 2010 and one from Hydro One Networks Inc. on behalf of Hydro One Remote Communities requesting that Hydro One Remote Communities be included on the list for rebasing in 2009. These comments have been posted on the Board's website.

After factoring the comments received into its analysis, the Board has decided to defer the rebasing of the rates of Essex Powerlines Corporation to 2010 and to include Hydro One Remote Communities on the list for rebasing in 2009.

The final lists of distributors whose rates will be rebased in 2009 and 2010 is set out in Appendices A and B respectively to this letter. All distributors named in Appendix A are requested to file a letter with the Board confirming that they will file a forward test year rate application by August 15, 2008 for rates to become effective May 1, 2009. All distributors named in Appendix B are requested to file a letter with Board confirming they will file a test year rate application by August 14, 2009 for rates to become effective May 1, 2010. The letter should be filed with the Board Secretary by **April 18 2008**, and state "**2009 and 2010 Distributor Rebasing, Board File EB-2006-0330**".
