IN THE MATTER OF the *Ontario Energy Board Act, 1998*, S.O.1998, c.15 (Sched. B);

AND IN THE MATTER OF applications by Centre Wellington Hydro, Veridian Connections Inc., EnWin Powerlines Ltd., Erie Thames Powerlines Corp., Chatham-Kent Hydro Inc., Essex Powerlines Corp., Cooperative Hydro Embrun Inc. and Hydro One Networks Inc. pursuant to subsection 74(1) of the *Ontario Energy Board Act, 1998* to amend Schedule 1 of their Transitional Distribution Licences.

PROCEDURAL ORDER NO. 10

Applications have been filed with the Ontario Energy Board pursuant to subsection 74(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B), by the following nine distributors for amendments to their licensed service area. These applicants and the Board's assigned file numbers are listed below:

The Board completed the hearing of evidence and submissions related to the general principles that should govern service area amendments, and issued its Decision on the principles on February 27, 2004.

The Board has now received correspondence from Veridian Connections Inc. withdrawing its EB-1999-0260 application and from EnWin Powerlines Ltd. withdrawing its EB-1999-0281 application.

The Board has also received correspondence from Erie Thames Powerlines Corp. proposing a revision to its application and requesting a final order of the Board on the application. This procedural order provides for the completion of the EB-2002-0462 application by Erie Thames.

In its original application, filed October 11, 2002, Erie Thames sought an amendment to its licence to include lands designated for a proposed new "Little Creek" subdivision development in Port Stanley. This subdivision is scheduled to proceed in phases 1 through 7. Phases 1, 2, 3 and 7 are in the licensed service area of Hydro One while phases 4, 5 and 6 are within the Erie Thames licensed service area.

By letter dated May 4, 2004, Erie Thames revised its application to seek an order of the Board to amend Schedule 1 of its Distribution Licence to include only phase 1 of the proposed development. The letter also indicated that Hydro One supports the revised application, and consents to the proposed amendment of Erie Thames' licence. This was confirmed in a letter dated May 31, 2004 from Hydro One. Both letters are attached as appendices to this procedural order.

Any party who wishes to make final written submissions with regard to the revised application of Erie Thames may file those submissions in accordance with this order. The Board reminds parties that the submissions should be targeted to the specific circumstances of the Erie Thames application, and that the application is supported by the incumbent distributor, Hydro One.

THE BOARD ORDERS THAT:

- 1 Parties who wish to make final written submissions with regard to the revised application of Erie Thames must file those submissions with the Board and copy them to all parties by Thursday June 24, 2004.
- 2 If the applicant Erie Thames wishes to respond to any submissions received, it must file those responses with the Board and copy them to all parties by Friday, July 2, 2004.
- 3 All filings to the Board **must be in the form of one electronic copy, in WordPerfect or Word format, and pdf format if possible, as well as 5 hard copies**, to be received by the Board by 4:45 p.m. on the stated dates. Each party must send its submissions to all other parties as well as to the Board.
