**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O.1998, c.15 (Sched. B);

**AND IN THE MATTER OF** applications by Centre Wellington Hydro, Veridian Connections Inc., EnWin Powerlines Ltd., Erie Thames Powerlines Corp., Chatham-Kent Hydro Inc., Essex Powerlines Corp., Cooperative Hydro Embrun Inc. and Hydro One Networks Inc. pursuant to subsection 74(1) of the *Ontario Energy Board Act*, 1998 to amend Schedule 1 of their Transitional Distribution Licences.

In accordance with the Board's Procedural Orders, parties to the proceeding have filed evidence and asked and answered a significant number of interrogatories. The Board now proposes to make provision for the oral portions of the proceeding.

Parties are invited to make final oral submissions to the Board on the principles that should guide the Board in determining service area amendment applications, commencing November 13, 2003. Parties should have regard to the Issues List established in Procedural Order No. 4 in crafting their submissions. Given the large number of parties to the proceeding, parties are requested to restrict their submissions to forty-five minutes in length (excluding questions from the Board). Parties will be expected to provide submissions in the order given in the List of Parties attached to this Order;

however, the speaking order can be changed on the consent of affected parties. Applicant parties may exercise a right of reply if it is necessary to deal with unexpected submissions from intervenors, but the Board requests that such reply submissions not exceed five minutes in length.

In establishing the attached list, the Board has grouped parties in the same manner as the parties grouped themselves in asking interrogatories. Further, in an attempt to identify "active" parties on the issue of principles, the Board has not included in the list those parties who are neither applicants, nor have asked interrogatories, nor have yet participated in arguments on principles or jurisdiction. If other parties to the proceeding wish to make submissions on principles, they are invited to write to the Assistant Secretary immediately upon receipt of this Order to request inclusion in the list. Parties are reminded that if they wish to support or oppose a particular application in this proceeding, they will have an opportunity to do so during the Board's consideration of the individual applications.

Following the receipt of oral submissions regarding principles, the Board intends to commence oral hearings for the remaining individual applications before it. The dates for those hearings are set out below.

## THE BOARD ORDERS THAT:

- 1 Commencing November 13, 2003, at 9:30 a.m. in the Board's hearing room at 2300 Yonge St., 25th Floor, parties may make oral submissions to the Board on the principles that should guide the Board in determining service area amendment applications. Parties will generally be expected to provide submissions in the order given in the List of Parties attached to this Order as Appendix A.
