FINAL ORDER

Wellington Electric Distribution Company (WEDCO), along with Guelph Hydro Electric System Inc., has filed an application dated January 13, 2005 with the Ontario Energy Board for a Final Order pre-approving its individual Conservation and Demand Management (CDM) Plan. The Board assigned File No. RP-2004-0203 / EB-2005-0203 to this application.

A Notice of Application and Written Hearing was issued by the Board on February 2, 2005. WEDCO served and published the Notice as directed by the Board. The intervention period expired on February 19, 2005. There were no intervenors.

On May 31, 2004, the Minister of Energy granted approval to all distributors in Ontario to apply to the Board for an increase in their 2005 rates by the third installment of their

incremental market adjusted revenue requirement (MARR). This approval is conditional on a commitment to reinvest an equivalent amount in CDM initiatives.

On October 5, 2004, the Board issued a Procedural Order (the Procedural Order) which addressed the opening of deferral accounts; the recovery of development expenses; the process for applying for plan approval; and the filing requirements for plan approval. Pursuant to the Procedural Order all electricity distribution companies, including WEDCO, received authorization to establish a deferral account.

The elements of WEDCO's CDM Plan include education and promotion, a low income program, traffic light retrofits and distribution system optimization.

The total budget for the CDM plan is \$23,723. This amount is consistent with the third installment of its incremental MARR.

The Board finds that the activities and programs proposed by WEDCO qualify as conservation and demand management activities and that the planned investments are eligible for tracking in the deferral account.

The Board approves the expenditure of \$23,723 for implementation of the CDM Plan, which is consistent with the amount of the third installment of WEDCO's incremental MARR.

The Board requires that WEDCO file with the Board quarterly and annual reports on the progress of the initiatives included in the approved CDM Plan. The annual reports will be subject to public review.

The Board understands that the approved CDM Plan and the associated budget allocation to the individual programs may be subject to modifications. The Board requires that all modifications be identified in the quarterly and annual reports. In

addition, WEDCO shall apply to the Board for approval for modifications of spending above 20% of the approved budget.

IT IS ORDERED THAT:

- 1. Wellington Electric Distribution Company is granted a final approval of the Conservation and Demand Management Plan as submitted for the Board's review in the application dated January 13, 2005. This investment satisfies the Minister of Energy's condition of a financial commitment to reinvest the equivalent of one year of incremental market adjusted revenue requirement in conservation and demand management. The approved total budget is \$23,723.
- Wellington Electric Distribution Company shall file with the Board quarterly and annual reports on the progress of the initiatives within its Conservation and Demand Management Plan.
- 3. The quarterly reports shall be filed no later than 30 days after the end of each calendar quarter.
- 4. The annual reports shall be filed no later than March 31 of the following year. The annual reports shall be subject to public review. The annual report shall include a cost benefit analysis on the program included in the Conservation and Demand Management Plan.
- 5. Wellington Electric Distribution Company shall apply to the Board for approval if cumulative fund transfers among programs exceed 20% of the approved budget.

6. Wellington Electric Distribution Company may credit the costs of preparing its Conservation and Demand Management application and participation in the hearing including intervenor and Board costs against the amount required to be spent on its Conservation and Demand Management Plan budget.
