VARY ORDER

In 2005, the Board approved investments in conservation and demand management ("CDM") plans filed by 87 electricity distributors, to be funded from the third installment of each distributor's market adjusted revenue requirement ("MARR"). The Board Orders to which these approvals relate were issued in the proceedings listed in Appendix A.

In each case, approval by the Board was conditional on the distributor filing with the Board annual and quarterly reports on the progress of the distributor's CDM initiatives.

On May 17, 2007, the Board released a report prepared by the Board's Chief Regulatory Auditor ("CRA") setting out the results of the CRA's review of the annual reports filed by distributors in relation to their MARR-funded CDM initiatives.¹ In that report, the CRA recommended to the Board that it consider eliminating the quarterly reporting obligation. The letter accompanying publication of the CRA's report requested interested parties to notify the Board if they believed that quarterly reporting should be maintained. The Board has not received any comments from interested parties requesting that quarterly reporting be maintained.

As noted in the CRA's report, a number of distributors have questioned whether the value of the quarterly reports outweighs the level of effort involved in producing them. The Board has now had the benefit of experience in relation to the filing and review of distributors' quarterly and annual CDM reports. On that basis, the Board has concluded that annual reporting is sufficient to enable the Board to adequately monitor and review the progress of CDM initiatives, and that quarterly reporting should no longer be a general requirement. Where warranted by the circumstances, the Board may subsequently require individual distributors to make more frequent filings.

THE BOARD THEREFORE ORDERS THAT:

The Orders of the Board issued in the proceedings listed in Appendix A are hereby varied by removing the requirement to file quarterly reports with the Board on the progress of the applicable distributor's conservation and demand management plan.
