MANAGER'S SUMMARY PETERBOROUGH DISTRIBUTION INC_Lakefield Smart Meter Addendum

This summary contains confidential and commercially sensitive information regarding the prices quoted by the meter manufacturer to the Coalition of Large Distributors and those utilities that piggybacked on the metering RFP. These prices are used in this application.

Peterborough Distribution Inc, Lakefield service territory, submits its 2007 Addendum for Smart Metering Rates application consistent with the guidelines provided in the rate_addendum_model and is requesting that Smart Meter Funding be increased to \$0.81 per metered customer.

Peterborough Distribution Inc. (PDI) made a decision to "piggyback" with the large utilities and purchase under the CLD plan and received the following pricing.

The total unit cost per smart meter of \$124.78 is comprised of the following cost:

A. Smart meter unit cost, total meter cost divided by meters: \$96.23

a. Average meter cost calculated as follows:
