NOTICE OF APPLICATION AND HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE Toronto Hydro-Electric System Limited

Toronto Hydro-Electric System Limited ("THESL") filed an application with the Ontario Energy Board, (the "Board") on August 3, 2007 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c.15 (Schedule B), seeking approval for changes to distribution rates that it charges for electricity distribution over a three year period, to be effective respectively May 1, 2008, May 1, 2009, and May 1, 2010. The Board has assigned the application File No. EB-2007-0680. The Board's decision on this application may have an effect on all of THESL's customers.

The standard electricity bill for residential and small general service customers has four line items: Electricity, Delivery, Regulatory and Debt Retirement Charge. This application affects the Delivery line of that bill. THESL is seeking approval of \$498.4 million in 2008, \$534.0 million in 2009, and \$562.4 million in 2010 as the forecasted revenues it requires to provide electricity distribution. If approved, THESL estimates a residential customer consuming 1,000 kWh per month would experience a decrease of \$0.23 in 2008, an increase of \$3.10 in 2009 and a further increase of \$1.59 in 2010 in the monthly electricity bill. A small General Service customer consuming 1,000 kWh per month and having a monthly demand of 50 kW or lower is estimated to see increases of \$2.62 in 2008, a second increase of \$3.87 in 2009, and a further increase of \$2.30 in 2010 in the monthly electricity bill.

You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than 10 days from the publication date of this Notice or, if you have been served this Notice directly, no later than 10 days from the date of service.

You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than 10 days from the publication date of this Notice, or, if you have been served this Notice directly, no later than 10 days from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board has chosen to hold an oral hearing. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
