RE: SERVICE QUALITY REQUIREMENTS PROCESS FOR SUBMISSION OF FILING UNDER THE NATURAL GAS REPORTING & RECORD KEEPING REQUIREMENTS

Section 7 of the Gas Distribution Access Rule (GDAR) sets out service quality requirements (SQRs) for natural gas distributors. These came into effect on January 1, 2007.

Under section 2.1.9 of the Natural Gas Reporting & Record Keeping Requirements, gas distributors are required to file, by the last day of the fourth month after the utility's financial year-end, a report on their performance against the SQRs in the preceding year.

To facilitate compliance with this filing requirement, Board staff has, in consultation with gas distributor staff, developed forms to be used for the electronic SQR reporting under the RRR. These forms will be available for use as of January 2, 2008 on the "e-Filing Services and Regulatory Document Search" page of the Board's website at <u>www.oeb.gov.on.ca</u>.

We have been provided with the names of persons authorized by each gas distributor to have access to the Board's web browser-based electronic filing system. If access for additional persons (up to a maximum of three in all) is required for purposes of the SQR filing, you should submit a "Registered User Application" in the form set out in Appendix A. by **January 25, 2008** to <u>Kelli.Dobson@oeb.gov.on.ca</u>. On receipt of the form, your designated staff will be contacted to complete the registration process.
