Re: Process for 2011 Incentive Regulation Mechanism ("IRM") Distribution Rate Applications

On July 9, 2010, the Board issued an update of Chapter 3 of the Board's *Filing Requirements for Transmission and Distribution Applications* (the "Filing Requirements"). This document supersedes version 1.0 of Chapter 3 of the *Filing Requirements for Transmission and Distribution Applications* dated July 22, 2009. The Filing Requirements outline the information that the Board requires an electricity distributor to file when it makes an application under an incentive regulation mechanism.

Schedule for Filings

In section 1.3 of the Filing Requirements, the Board indicated that it would assign electricity distributors to one of the six filing tranches noted below based on the expected level of complexity of the application. The deadlines for filing an IRM application were based on being able to issue a Decision and Order in time for a May 1 implementation date.

The application deadlines are as follows:

Board staff issued a survey requesting that distributors identify the expected elements to be contained in their respective IRM applications. Based on that information the Board assigned each of the electricity distributors scheduled to file a 2011 IRM application to one of the tranches identified above. Distributors are not required to

include in their applications the elements that they identified in the survey, except for those elements that must be included based on the Filing Requirements or a prior Board decision. The information from the survey was used solely for scheduling purposes.

Table 1 below provides a detailed listing of electricity distributors and their respective tranches. The Board expects distributors to submit their applications by 4:45 pm on or before their respective due date.

The Board is mindful of the fact that some distributors listed below have Cost of Service applications currently before the Board for the setting of their 2010 distribution rates. The date identified below for those distributors is a placeholder. Following the issuance of their 2010 Rate Orders, each distributor should notify the Board in writing of the expected filing date of its 2011 IRM application.

2011 2nd and 3rd Generation Rate Generators
