REVISED RATE ORDER

Introduction

Oakville Hydro Electricity Distribution Inc. ("Oakville Hydro"), a licensed distributor of electricity, filed an application with the Ontario Energy Board (the "Board") on September 17, 2010, under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Oakville Hydro charges for electricity distribution, to be effective May 1, 2011.

In its Rate Order on the Application issued on April 7, 2011, the Board ordered Oakville Hydro to review the draft Tariff of Rates and Charges and to file with the Board a written confirmation assessing the completeness and accuracy of the draft Tariff of Rates and Charges, or provide a detailed explanation of any inaccuracies or missing information, within seven calendar days of the date of the Decision and Order. On April 13, 2011, Oakville Hydro filed a letter noting some errors in the Deferral and Variance Account Workform and the draft Tariff of Rates and Charges.

The Board accepts Oakville Hydro's submission and has revised the Tariff of Rates and Charges.

THE BOARD ORDERS THAT:

 The revised Tariff of Rates and Charges set out in Appendix A of this order will become final effective May 1, 2011, and will apply to electricity consumed or estimated to have been consumed on and after May 1, 2011. Oakville Hydro shall notify its customers of the rate changes no later than with the first bill reflecting the new rates.
