Re: Process for 2012 Incentive Regulation Mechanism ("IRM") Distribution Rate Applications

On June 22, 2011, the Board issued an update of Chapter 3 of the Board's *Filing Requirements for Transmission and Distribution Applications* (the "Filing Requirements"). The Filing Requirements outline the information that the Board requires an electricity distributor to file when it makes an application under an incentive regulation mechanism.

The Board had indicated that it would assign electricity distributors to one of the six application groupings noted below based on the expected level of complexity of the application. The application filing deadlines were determined so that, in the normal course of events, a Decision and Order would be issued in time for a May 1 implementation date.

The application groupings are as follows:

On June 22, 2011 Board staff issued a survey to all electricity distributors scheduled to file a 2012 IRM application to provide the expected elements that will be contained in their application. Following the results of the survey, the Board has assigned electricity distributors to the six application groupings. Please refer to the table below for a detailed listing of electricity distributors under each tranche. The information filed in the survey is not binding on distributors. If a distributor contemplates a material increase to the complexity of their application, it should file in an earlier tranche.

Some distributors, not scheduled for rebasing in 2012, have nonetheless filed a notice of intent to file a cost of service application for the 2012 rate year. Those distributors will not be assigned to an IRM application grouping until such time as the Board has made a determination on their application.

The Filing Requirements also established a filing deadline of August 15, 2011 for those distributors whose rate year has been aligned with their fiscal year for a January 1, 2012 implementation date.

All filings to the Board must quote the pre-assigned file number and be made through the Board's web portal at <a href="www.errr.ontarioenergyboard.ca">www.errr.ontarioenergyboard.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="www.ontarioenergyboard.ca">www.ontarioenergyboard.ca</a>. If the web portal is not available parties may email their document to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
