NOTICE OF INTENTION TO MAKE AN ORDER FOR COMPLIANCE AND TO IMPOSE AN ADMINISTRATIVE PENALTY UNDER s. 112.3 and 112.5 of the ONTARIO ENERGY BOARD ACT, 1998

The Ontario Energy Board (the "Board"), on its own motion under section 112.2 of the *Ontario Energy Board Act, 1998* (the "Act"), intends to make an Order under sections 112.3 and 112.5 of the Act requiring Direct Energy Marketing Limited ("Direct Energy") to comply with a number of enforceable provisions as defined in section 3 of the Act and to pay an administrative penalty in the amount of \$20,000 for breaches of enforceable provisions.

Ernst and Young LLP (E&Y) was retained by the Board to conduct compliance inspections of Direct Energy's operations in order to ensure compliance with all applicable legal and regulatory requirements pertaining to consumer protection. In order to carry out the inspection, E&Y staff required access to relevant data related to Direct Energy's transactions and processes, as well as access to information in their data systems. E&Y provided a final report of its findings to Board staff along with supporting documentation. Board staff then reviewed the findings.

ALLEGATIONS OF NON COMPLIANCE

It is alleged that Direct Energy has contravened sections 7(1)11 of Ontario Regulation 389/10, section 12 of the *Energy Consumer Protection Act, 2010* (the "ECPA") and section 3.8 and 3.9 of the Electricity Retailer Code of Conduct and sections 3.6 and 3.7 of the Code of Conduct for Gas Marketers.

PARTICULARS

The particulars in support of the allegations set out in this Notice are as follows:

Contract Content Requirements for Renewal Contracts

1. With respect to 25 electricity contracts and 25 gas contracts reviewed, the renewal contract fails to state that "nothing in the contract negates or varies the consumer's rights to cancel the contract under and in accordance with the Act and this Part" as required by section 7(1)11 of Ontario Regulation 389/10. The specific contracts referred to in this paragraph are listed in the attached Appendix A.

Transfer requests where consumer enters into contract with another company

2. Direct Energy provided the E&Y inspectors with a system-generated list which indicated that 393 notices of a pending transfer request were received by Direct Energy from a distributor for the period January 1 to February 14, 2011. For each notice of pending transfer received from the distributor Direct Energy, in response to inquiries made by E&Y inspectors, confirmed that it did not notify the consumer of the pending transfer request contrary to sections 3.8 and 3.9 of the Electricity Retailer Code of Conduct and sections 3.6 and 3.7 of the Code of Conduct for Gas Marketers. E&Y also confirmed that in each of the 393 cases Direct Energy confirmed that it decided not to send a notice as it was not charging the consumer any cancellation fees.

THEREFORE TAKE NOTICE that Direct Energy may request, within fifteen days after receiving this Notice, that the Board hold a hearing on these matters. If no request for hearing is made within this time period, the Board may proceed to make an Order that Direct Energy comply with any of the enforceable provisions listed in this Notice and that Direct Energy pay an administrative penalty.

FURTHER TAKE NOTICE that if a hearing is requested, the Board is not bound by the above noted penalty and has discretion, upon finding a contravention(s) of the Act, to make any order it deems appropriate under sections 112.3 and/or 112.5 of the Act. Direct Energy is entitled to be present at the hearing with or without counsel and to adduce evidence and make submissions. Should Direct Energy fail to attend, the hearing may be conducted in its absence and Direct Energy will not be entitled to any further notice in the proceeding.
