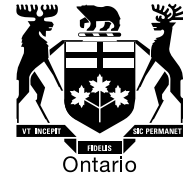

On January 24, 2013, the Board issued a letter inviting participation of interested parties in a working group and a consultation process for the Development of a Standby Rates Policy for Load Displacement Generation. In the letter, the Board also noted that it was seeking the assistance of a consultant to assist in this consultation process.
