RE: 2015 Natural Gas Market Review – Forum Planning

In a letter dated November 25, 2015 (<u>cover letter</u>) the Board announced its 3rd Natural Gas Market Review consultation, which includes a Forum to be held at the OEB's offices on Thursday, January 21, 2016.

The purpose of the Forum is to examine ongoing developments and related issues in the North American natural gas market and assist the OEB's consideration of any potential impacts – including regulatory implications – of such developments for Ontario's natural gas market.

This letter provides an update on preparations for the Forum, including the posting today of a *2015 Natural Gas Market Review* <u>Summary Report</u> and Forum <u>slide</u> <u>presentation</u> prepared for OEB staff by Navigant. These materials address the key factors influencing current North American and Ontario natural gas market trends and provide a forecast of natural gas supply, demand and prices.

Forum planning

To help develop a preliminary draft agenda, the cover letter invited stakeholders to provide feedback on four broad areas of interest. Stakeholder responses, posted on the <u>2015 NGMR</u> webpage, were considered in developing the three main areas of discussion outlined on the attached preliminary draft agenda:

• The first session will review recent market developments, focusing on how market drivers have evolved since the previous NGMR and affected the forecast of North American and Ontario natural gas supply, demand and prices

- The second session will provide an opportunity to discuss current market conditions and resulting approaches to natural gas purchasing. Note that distributor gas supply plans are the subject of a <u>separate consultation</u> currently in progress and are therefore not within the scope of this session
- A third, forward looking session will focus on forecast North American and Ontario natural gas market trends over the next few years and any potential market and regulatory implications thereof

This general Forum plan will be further refined on the basis of stakeholder expressions of interest in giving a presentation at the Forum on one or more the indicated subject areas. As noted below, such expressions of interest should be sent to NGMR@ontarioenergyboard.ca by Friday, January 8, 2016. However, stakeholders planning to give a presentation should note that the deadline for filing a Forum presentation with the OEB has been extended to Friday, January 15, 2016.

Forum overview

The Forum will begin at 9:30 a.m. on Thursday, **January 21, 2016** with opening remarks by Ontario Energy Board Chair and CEO Rosemarie T. Leclair. Each session will consist of participant presentation(s)/remarks (see Participant Presentations below) followed by questions and discussion. Forum proceedings will not be transcribed.
