“Market Participant identifiers will be self-selected and registered with the OEB to ensure uniqueness within Ontario. The format will be exactly 10 alpha numeric characters. Numeric values that are less than 10 digits must be padded with non-space characters. Possible identifiers that Market Participants may choose from include (but are not limited to) OEB licence number, Dun & Bradstreet identifier, and GST registration number.”
