On June 23, 2021 the Ontario Energy Board (OEB) initiated a consultation to renew its Innovation Sandbox.

Over the summer, OEB staff has been holding one-on-one and small group meetings with interested stakeholders to discuss opportunities for Sandbox renewal.

As the next step in this consultation, the OEB will hold a virtual stakeholder event on **September 30, 2021** from 1:00pm to 4:00pm to describe OEB staff's proposed changes to the Innovation Sandbox. Elements of its proposed Sandbox 2.0 design will be based on the input received during the one-on-one and small group meetings held with participants in July and August. Materials will be made available in advance of the meeting.

Stakeholders who intend to participate in the September 30 stakeholder event are asked to email notice of their intention to [innovation@oeb.ca](mailto:innovation@oeb.ca) by **September 17, 2021**. Stakeholders who have indicated their interest in participating will receive details regarding the event in due course.

#### Written Feedback on Draft Sandbox 2.0 Design

Following the stakeholder meeting, participants will have the opportunity to provide written input on the draft Sandbox 2.0 design, which must be submitted to the OEB by

**October 15, 2021.** Prior to and during the September 30 meeting, OEB staff will provide guidance on any issues or design choices on which input would be of particular value to OEB staff.
