RE: Status of policy initiatives during the transition to a new governance

structure

On May 9, 2019, amendments to the *Ontario Energy Board Act, 1998* were given Royal Assent and will, when proclaimed into force, materially change the Ontario Energy Board's (OEB) corporate governance structure.

In his <u>April 17, 2019 letter</u>, the Minister of Energy, Northern Development and Mines indicated that approval of the OEB's Business Plan for the fiscal year 2019-20, including the proposed budget envelope, is intended to facilitate the OEB's transition to the new governance structure and provide some certainty during that process, while recognizing that the new legislation may impact the OEB's programs and activities and noting that the prudent use of funding is expected of all provincial agencies.

The OEB intends to act with prudence during the transition to the new governance structure, in keeping with the expectations articulated in the Minister's April 17, 2019 letter. Following consultation with Ministry staff, the OEB has identified a number of policy initiatives that have been launched and are in progress and for which the OEB will defer further external stakeholder engagement activities during the transition. Any outstanding cost awards matters related to these initiatives will be addressed in the near term. The OEB will consider these initiatives further once the new governance structure is in place.

A number of other policy initiatives that may include stakeholder engagement activities during the transition are moving forward. This will enable the OEB to progress on issues of importance to the sector and its future, and to gather further stakeholder

insight to inform the development of a new strategic vision once the new governance structure is in place. In developing future stakeholder engagement activities for these initiatives, the OEB will be mindful of the Modernization Review Panel's emphasis on the importance of clear, open and transparent stakeholder processes in policy consultations, subject to the statutory requirements that govern the process for making natural gas rules and electricity codes.

Further detail regarding the status of OEB policy initiatives is set out in Appendix A. The OEB's adjudicative and consumer protection work, the continuity of which was recognized as being of critical importance in the Minister's <u>March 21, 2019 letter</u> to the OEB, will continue without interruption during the transition.

The OEB is working closely with the Ministry to ensure as seamless a transition to the new governance structure as possible, and as always remains committed to the effective and efficient performance of its mandate to regulate the electricity and natural gas sectors in the public interest during the transition and beyond.
