Background

- All utilities required to submit cost allocation informational filings starting in the fall 2006
- Updated utility-specific load profiles are required as input
- Questionnaire sought information on utilities' plans

Purpose of Today's Workshop

- To continue the consultation and information-sharing with utilities and stakeholders
- To review OEB cost allocation model load data requirements
- To provide information to assist utilities in preparing their load profiles
 - all LDCs using Ontario Load Data Research group's generic load data for GS > 50 and residential classes
 - nearly all LDCs using HONI's load data analysis team
 - 50 LDCs have confirmed will be doing appliance saturation surveys
