#### **Division Overview:**

The Applications Division is responsible for managing and processing all proceedings relating to rates, facilities, and conservation, as well as operational policies in support of applications. It also conducts research on emerging energy issues. The Division is comprised of four departments: Supply & Infrastructure, Major Rate Applications, Incentive Rate Setting & Accounting, and Application Policy & Climate Change.

Within the **Rates department**, the **Major Applications** department is responsible for assessing and coordinating the analysis of applications relevant to **rate-regulated electricity and natural gas** businesses in Ontario. The department manages rate and other applications from utilities, resolving issues, providing professional support on a wide variety of technical issues and subjects, and assisting the Ontario Energy Board (OEB) in its processes and ensuring completion of the official record.

#### **Key Responsibilities:**

Your responsibilities in the Major Applications Department will include:

- Reviewing and summarizing past decisions made by the OEB on key issues relating to rate applications
- Analyzing, identifying and summarizing stakeholder issues in applications
- Updating informational databases to support future reviews of applications
- Provides ad hoc research and analysis reports on various issues for case managers, Project Advisor and Manager
- Assists in preparing correspondence, briefing notes and writing reports as required

### Qualifications

Candidates for this position should possess the following:

- Strong analytical and critical thinking skills to identify key issues
- Proficiency with the adjudicative process.
- Exposure to reviewing legislations, policies and Board Panel decisions
- Strong oral and written communication skills are a must.
- Enrollment in an undergraduate program in Public Policy & Governance or Administration, Economics, Business, Engineering or a related post-graduate studies program is an asset.
